- Meeting was called to order by Bobby at 7:10 PM.
- Officers for the next term were voted in:
  - Bobby Riggs II – Vice President
  - Doug Connelly – Treasurer
- Secretaries report was reviewed and approved
- Treasurers report was reviewed and approved
- DC United will open the registration for the fall soccer camp though the high school age to anyone to insure sufficient participation.
  - DC United will host a clinic on Wednesday evening @ Middletown High School – it will be free for FCYSL Coaches
    - Interested participants need to let Bobby know since there is a 50 person limit.
  - After review of this year's participation, DC United will reassess which clinics will be sponsored next year.
- Spring Season – tournament move-up philosophy will be used to try to get the teams that were placed in the wrong divisions challenged for the tournament.
  - Discussion regarding team placement ensued.
  - The agenda needs to include the structure of the tournament
- PVYA brought forth the question on what constitutes league member, and whether areas should be classified as AMP's since they may not meet the requirements for FMP's. Each area was questioned and determined whether which way they would be classified for this season.
- PVYA suggested that the formation of a committee to determine how to build the league, and develop a stronger division I bracket. Discussion ensued.
  - Proposal to amend the by-laws to permit more than 5 carded players on a team with the caveat that they would be required to play in Division I. The by-laws would be further clarified to state that the definition of carding is for higher level league play, not for tournament participation. The vote carried with 9 Yay, 3 Nay and 2 Abstains.
- WMPT requested a waiver to maintain an overage player t the U-12 level for the purposes of transportation. The vote did not carry with 4 Yay, 7 Nay and 3 Abstains.
- TJAY requested a waiver for three 14 year olds that are still in middle school to participate at the U-14 level. The vote carried with 14 Yays.
- Meeting was adjourned.
